

"Communication happens when a message is received and understood."

The risk is that we may assume that because we explain a concept in a way that we feel to be simple and comprehensible, that may not be the case. The proof often only comes out when the learner has completed the assessment and then you realise they have not fully understood. In a classroom this can be managed through remedial courses. But what about the working environment? Can you be sure that your messages and briefings have not only been heard but that the personnel also understand what they need to know and what they need to do.

"In the study of Human Performance and Human Factors, lack of Communication is one of the key factors that lead to human error and individuals making mistakes."

Perhaps we all need to review how well we get our messages across. As an example, I attended a conference which focused on how e-commerce solutions can help maximise business. As our express logistics industry is one of the cornerstones in this fast-growing e-commerce environment it was stimulating to learn about the innovative ways in which retailers and other e-commerce environments are forming partnerships with various providers to find delivery solutions.

The dark side however were numerous instances of fake e-commerce retail sites where customers are scammed. As partners in the e-commerce environment, I think members should work with clients and share security tips that they can pass on to their customers to avoid being hoodwinked.

the right message when we communicate information about Security Culture and Dangerous Goods. We know what we mean to say but are the posters in the workplace doing the job? As an Instructor, I daily challenge my assumptions about what my learners understand and I strive to simplify my message without losing the impact.


